

Executive Officer Notice: Updated Income Eligibility Thresholds for the Seniors Co-Payment Program under the Ontario Drug Benefit Program

May 9, 2024

The income eligibility thresholds for the <u>Seniors Co-Payment Program (SCP)</u>, under the Ontario Drug Benefit (ODB) Program are being updated from \$22,200 to \$25,000 (for single seniors¹) and \$37,100 to \$41,500 (for senior couples²) effective August 1, 2024.

These updates ensure that the SCP income eligibility thresholds better reflect cost-of-living increases in Ontario and continue to be in line with increases to income supports for seniors.

On the first day of the month after they turn 65 years of age, all OHIP-insured Ontarians are automatically enrolled in the ODB program, which covers most of the costs of more than 5,000 prescription drug products. Generally, seniors pay the first \$100 of their prescription drug costs each year (annual deductible) before they are eligible for drug coverage.³ After the deductible is paid, seniors then pay up to \$6.11 toward the dispensing fee for every prescription (a co-payment). The SCP is an application-based program under the ODB for seniors with incomes less than certain income eligibility thresholds. Seniors enrolled in the SCP pay no annual deductible and a reduced co-payment of \$2 per each prescription, improving access to essential drugs.

Ontarians who are currently 65 years of age or older, or turning 65 on or after July 1, 2024, and who meet the new income eligibility thresholds, are encouraged to apply to the SCP starting in May 2024 in advance of the start of the upcoming Benefit Year (August 1, 2024). This will ensure that those who qualify for the SCP will benefit from the elimination of the annual deductible and a reduction in their co-payments beginning August 1, 2024, and minimize the chance of out-of-pocket expenses.

¹ A "single senior" includes a senior who is no longer cohabiting with a spouse for certain reasons.

² A "senior couple" means a senior who cohabits with a spouse.

³ For the first year of ODB program eligibility as a senior, depending on when the senior turns 65, the deductible may be lower than \$100.



To avoid unnecessary delays and ensure timely processing, applicants can complete the Seniors Co-Payment Program Application available on the <u>Ontario Drug Benefit Program</u> <u>Online Applications and Forms website</u> at: <u>https://forms.ontariodrugbenefit.ca/</u>.

The online form will guide them through the application process to ensure all the information required for enrolment is provided before submission.
